Program Guidelines

- **Class Eligibility:** Sign Manufacturers, Sign installation, Outdoor Advertising, Sign Shops and Awning Shops (75% of payroll must be within classes)
- **Ineligible Exposures:** Risks working in NYC's 5 boroughs or performing work in excess of 6 feet in the state of New York; Risks working in Cook County, IL
- **Lines of Business:**
 - **General Liability** (limits up to \$1M per occurrence/\$2M aggregate)
 - **Product Liability** (limits up to \$1M per occurrence/\$2M aggregate)
 - **Auto Liability** (limits up to \$1M per occurrence)
 - **Property / Inland Marine** (limits up to \$500K)
 - **Workers' Compensation** (Statutory Limits)
 - **Umbrella Liability** (limits up to \$10M)
 - **Garage Keepers Liability**
 - **Limited Pollution Liability Extension Endorsement**
- **Available Special Coverages:**
 - Printers Errors & Omissions Liability Coverage
 - Liability coverage for truck-mounted cranes and installation
 - AD&D Coverage (limits up to \$100,000)
 - GL Amendatory Endorsement
 - Additional Insured – Required by Written Contract
 - Per Project Aggregate
 - Primary Wording and Waiver of Subrogation Available
 - Enhanced Building and Personal Property Forms
 - Additional Coverages: Computer Equipment (\$250,000); Media, Data & Programs (\$100,000)
 - Coverage Extensions: Accounts Receivable Records; Personal Effects and Property of Others; Property off Premises; Off Premise Utility Failure – Property Damage
- **Minimum Premiums:** \$1,000 GL
- **3 year Loss Runs:** Incurred 3-year loss ratios less than 50%
- **Highlights:** AM Best A Rated (Excellent) Carrier (Company Size XV), Competitive Rates, Attractive Commissions, Superior Customer Service

- Five year currently valued hard copy loss history from insurance carrier

Workers' Compensation

- Description of safety initiatives, hiring practices, return to work and drug testing programs
- Experience Modification Worksheet and 3 - 5 year history, if available (helps speed processing)
